INTRODUCTION

The Clinical Patient Management System (CPMS) IT platform for clinical consultations between ERN members supports Health Professionals by facilitating collaboration with a network of experts across national borders of member states in Europe. It promotes improvements in the diagnosis and treatment of rare or low prevalence complex diseases within the EU. CPMS reporting tools allow users to generate reports of interest for administrative and clinical purposes.

The ERN-CPMS system is a secure Software as a Service (SaaS) that enables Health Professionals to enrol patients using comprehensive data models. Health professionals can use the ERN-CPMS to collaborate actively and share patient data within and across ERNs.

The ERN-CPMS is supported by Virtual Communication Tools and DICOM viewers to facilitate the interaction between clinicians.

Note The ERN-CPMS system may change as suggestions from our clinical advisors are incorporated, particularly in the area of interface and reporting.

GETTING STARTED

SUPPORTED BROWSERS

The ERN-CPMS system is a web-based application and is accessed using a web-browser. The latest versions of the following browsers are supported:

- Google Chrome recommended for best experience of all ERN-CPMS system features.
- Mozilla Firefox
- Safari

JavaScript must be enabled in all browsers.

Private/incognito browsing modes should not be used when accessing the ERN-CPMS system.

Notes Use of the Safari browser is not recommended – users may experience problems when joining video meetings, sharing screens or with webinars.

ACCESS ERN-CPMS

Access to the ERN-CPMS system is strictly regulated to protect the data privacy rights of the patients.

An EU Login account is required for access to the system – the **click here** links on the *Login* page provide access to the EU Login site from where an account can be created, or authorisation to use the CPMS can be requested. See the EU Login guide for details – https://ecas.ec.europa.eu/cas/help.html.

Guest accounts with a Guest Virtual Centre within the ERN-CPMS can be requested by Network Coordinators – see the <u>ERN-CPMS Support Desk</u> section above for details.

A user's access to ERN-CPMS features is determined by their role within the System – see the <u>Roles and Rights</u> section of the Appendix for details – and the Centre and Network that they belong to.

LOGIN TO ERN-CPMS

In compliance with the guidelines published by The European Union Agency for Network and Information Security (ENISA), login to the ERN-CPMS system is protected by a Two-Factor Authentication mechanism.

- 1. Click Login via EU Login and provide a valid email address in the box provided.
 - Follow the on-screen instructions to complete the first step of login authentication.
- **2.** Select a **Verification method** for the second step of the authentication.
 - Follow the on-screen instructions to complete the login process.

FIRST TIME LOGIN

The first time the user accesses the ERN-CPMS system they will be prompted to Accept the confirmation of the Professional Code of Conduct.

The user ERN preferences are set to None by default. It is recommended that the user updates the areas of interest as soon as possible after first logging in to ensure they are correctly available to other ERN users when setting up panels or scheduling meetings. See the <u>ERN Preferences</u> section below for more details.

Non-EU Users (Test Only)

Users that do not have an EU Login profile and must login with a password.

- 1. Click the **To use non-eulogin users, click here (test only)** link below the Login via EU Login button to open the login page.
 - Type the Username and Password in the boxes provided.
- **2.** Click **Secure Login** to complete the login.

NAVIGATING THE ERN-CPMS SYSTEM

A module within the ERN-CPMS system is a predefined set of security rules, dashboards, forms and reports created for a specific requirement. Each Centre or ERN within the ERN-CPMS is a separate module, ensuring the security and segregation of confidential patient data within the system.

The data for each Healthcare Provider using the system is isolated within a Centre. Users associated with a particular Centre cannot access the patient-identifying data for other Centres.

THE CPMS GLOBAL DASHBOARD

After successfully logging in to the ERN-CPMS system the user will be brought to the *CPMS Global Dashboard*, from where they can access all the functionality of the ERN-CPMS system.

The *CPMS Global Dashboard* gives the user an overview of upcoming meetings, outstanding meeting or panel invitations and recent panel activity. It provides the user with immediate access to their active panels and meetings and options to instantly take action on panel or meeting invitations.

The blocks on the *CPMS Global Dashboard* include up to 10 rows of information on meeting and panels across all ERNs and Centres.

- The user can return to the CPMS Global Dashboard at any time.
 - Click the ERN logo or CPMS link in the Header Menu.
 - o Click the **Dashboard** link in the *Side Menu*.




Figure 1 - The CPMS Global Dashboard – see below for details.

- a. Click to expand a block and view additional information.
- b. Click a Panel ID to go directly to the selected panel. See the Working with a Panel below for details.

- **c.** The *Upcoming Meetings in the next 14 days* block contains a summary of meeting scheduled within the next fortnight.
 - Click a **Meeting Title** to go directly to the selected meeting. See the <u>Participating in Meetings</u> below for more details.
 - o Click the icon to download the iCal for the meeting; confirmation of the action may be required depending on the browser configuration. The iCal can be used to automatically update a local calendar.
- **d.** The *Meeting Invites* block contains a summary of meeting invitations awaiting action.
 - Click a **Meeting Title** to go directly to the selected meeting. See the <u>Participating in Meetings</u> below for more details.
 - Click the **Vote** button to open the *Meeting Timeslot Selection* page. See the <u>Vote for a Proposed Meeting Time</u> below for more details.
 - The **Refuse** or **Accept** buttons in the *Meeting Invites* block can be used to instantly respond to the selected invitation.
 - If the invitation is Accepted the meeting will be moved to the *Upcoming Meetings* block.
- **e.** The *Panel Activity in the last 14 days* block contains a list of panels with actions taken in the last fortnight.
 - Click the **View Activity** button to view a summary of the panel activity.
- f. The Panel Invites block contains a summary of panel invitations awaiting action.
 - o Click the View Activity button to view a summary of the panel activity.
 - Use the **Refuse** or **Accept** buttons in the *Panel Invites* block to instantly respond to the selected invitation.
 - o If the invitation is Accepted, the Panel will be displayed in the *Panel Activity* block.

Note Additional blocks may be displayed on the *CPMS Global Dashboard*, and the layout may differ depending on the user's role within the system. See the <u>Roles and Rights</u> appendix for details.

THE HEADER MENU

The *Header Menu* is shown on all pages within the ERN-CPMS system and provides quick navigation of the ERN-CPMS system features. The items shown will depend on the user's role within the system.

All of the items in the *Header Menu* are clickable – providing navigation to the Centre, ERN or Global *Dashboard* or to other features and applications.

Click **the ERN logo** or **CPMS** link in the *Header Menu* to return to the *CPMS Global Dashboard* at any time.

- **a.** The currently selected module, Centre or ERN will be shown on the left of the bar and indicated by a highlighted text in the *Header Menu*.
 - Click the **Centre** or **ERN link** to return to the *Centre/ERN Dashboard* at any time.
 - o Click the **ERN logo** or **CPMS link** to return to the *CPMS Global Dashboard* at any time.
- **b.** Occasionally, an Announcement banner will be displayed above the Header Menu to make essential service announcements.






- **c.** If the current user is enrolled in more than one Centre or ERN the drop-down menu can be used to select which Centre or ERN to work in.
- d. Click **Training** to open the ERN-CPMS Training module.
 - The training pages open with the user guide (this document) displayed.
- **e.** Click **Help & Support** to access the *Help Menu* for quick access to Help and Support, Frequently Asked Questions and release documentation.
- **f.** The current user's name is shown at the top right of the *Header Menu*. Click the **user name** to open the *User Menu*, from where the user can change their password, upload a secure file, update the personal details and notification settings or log out of the system. See <u>The User Menu</u> section below for details.
- g. When working on the patient pages, an arrow is shown on the left of the *Context Banner*. Click the **arrow** to return to the original page.
- **h.** The *Context Banner*, displayed below the *Header Menu*, contains details of the current activity and currently selected patient or Centre.

THE USER MENU

The User Menu provides to the User Settings page and to manual Logout.



Depending on the user's profile, access to additional features and modules, such as Secure File Upload or Scheduled Reports will be available here. See the <u>Roles and Rights</u> appendix for details.

A user's role or areas of interest can be updated as they change; see the <u>ERN Preferences</u> section below for details.

CHANGE PASSWORD

In order to maintain security, it is recommended that passwords are changed regularly.

- 1. Click user@centre details in the *Header Menu* to open the *User Menu*.
- 2. Select **Change Password** to open the *Change your password* page.
- 3. Type the new Password in the box provided.
- **4.** Type the same password in the **Password (again)** box.
- 5. Click **Set Password** to save the new password.
 - Click **OK** to close the confirmation window.
 - The user will be logged out and must use the new password to login again.

The following rules apply to passwords:

- They must be at least 10 characters long.
- They must contain at least one:
 - o lower case character, e.g., a-z
 - o upper case character, e.g, A-Z
 - o number, e.g, 0-9
 - special character, e.g, !@#\$%^*()_+-={}|[]&:",

- They must not be:
 - o one of the last 10 passwords used.
 - o similar to the user's first or last name.
 - o similar to the user's login name or email address.

SECURE FILE UPLOAD

The Secure File Upload option in the user menu can be used to transfer files to the ERN-CPMS support team, when reporting issues with the ERN-CPMS system.

The Comment box should be used to provide details of the reason for uploading the file, for example, reference to a telephone call or support desk ticket number.

Notes Patient identifying sections in files are NOT removed during upload; please de-identify any files before uploading.

• Files uploaded are for the support of the ERN-CPMS system; any files uploaded will be deleted as soon as the associated issue has been resolved.

USER SETTINGS

The logged in user can view and update the personal details and notification.

- 1. Click the **username** to the right of the *Header Menu*.
- 2. Click **User Settings** in the drop-down menu to open the user's *Preferences* page.

See the <u>Preferences</u> section below for details.

LOGOUT

When the user is finished using the ERN-CPMS system, or is leaving the workstation unattended, they should log out of the system to prevent unauthorised access to patient information.

- 1. Click the **username** to the right of the *Header Menu*.
- 2. Click **Logout** in the drop-down menu.

THE SIDE MENU

While working within the ERN-CPMS system, a navigation menu is displayed to the left of the screen.




Figure 4 - Example Dashboard and Patient Side Menus - see below for details.

- **a.** The Dashboard option at the top of the Side Menu can be used to return to the *CPMS Global Dashboard*.z
 - All menu items can be clicked to open the selected page.
- **b.** The *Side Menu* can be used as visual guide to the user's location within the ERN-CPMS system.
 - The menu items change colour to indicate that they have been selected.
- **c.** Occasionally a user may belong to more than one ERN or Centre; in this case an ▶ arrow will be displayed in the *Side Menu*.
 - Click the menu option to choose from the available ERNs or Centres.
- **d.** The colour of the side bar, icons and items displayed in the *Side Menu* will vary depending on the user's current activity.
 - In the examples shown, the side bar and selected items are dark purple when working on the *CPMS Global Dashboard* and are dark green while working with the Patient pages.
- **e.** The currently selected item is highlighted and indicated by a **<** notch in the menu.
 - The examples above show Preferences and Patient Documents selected.

Notes The options available in the *Side Menu* will vary depending on the user's location within the ERN-CPMS system.

• The user's role within a Centre or ERN also affects the options in the *Side Menu*. See the <u>Roles</u> and Rights appendix for details.

MAP

The Map option on the *CPMS Global Dashboard Side Menu* opens the European Commission | European Reference Networks search facility. This is external to the ERN-CPMS System; the user must use browser navigation to return to the *CPMS Global Dashboard*.

- a. A full user guide to the ERN Search tool is available on the map page.
- **b.** Use the + and buttons to zoom the Map.
 - Click and drag to the map to focus on a specific location.
- **c.** Use the drop-down menus above the map to filter the list of HCPs displayed by ERN, County and Centre.
- d. The selected ERNs and Centres are displayed below the map.
 - o Click an item to view the ERN/Centre details.

Note Use the browser navigation to return to the CPMS Global Dashboard.

TRAINING

The Training module provides access to the various reference and training documents and materials that detail the use of the ERN-CPMS system.

Note To facilitate the display of all reference and training material, the *Training* module is displayed without a *Side Menu*; click **the ERN logo** or **CPMS** link in the *Header Menu* to return to the *CPMS Global Dashboard*.

By default, the Training module opens with this document displayed.




Figure 6 - The ERN-CPMS Training Module document viewer – see below for details

- **a.** Click + to expand or close a block. Click an item the block to open the selected document.
- **b.** When viewing files in the User Guides block, the Download PDF button can be used to download the document for local reference.
- **c.** When viewing files in the User Guides block, the usual PDF viewing options are available to locate sections, resize and print the document.
- **d.** A number of the files in the User Guides block include a document outline to allow for easy location of specific information.
 - o Click **≡** to view the document outline
 - o Click the ▶ arrow to view the full section content; click the ➤ arrow to hide a section
 - Click the highlighted Section title to jump to the selected Section.

TRAINING VIDEOS AND WEBINARS

Training videos provide short how-to demonstration of key tasks in the ERN-CPMS system; and webinars are recordings of ERN-CPMS system training sessions. They are displayed using a standard video player.




Figure 7 - The ERN-CPMS Training Module video viewer – see below for details.

- **a.** Click **+ -** to expand or close a block. Click an item the block to open the video or webinar.
- b. After loading, the video or webinar will automatically start playing.
- c. While viewing Training Videos, after the introduction is complete, the time remaining is displayed.
- **d.** The control bar at the bottom of the screen provides the following options:
 - o Click / Pause / Play the video.
 - o Click **◄**) to adjust the volume.
 - o Drag the play indicator left to replay or right to skip forward.
 - The time remaining is indicated to the right of the play-bar.
 - Click: to play the video in full screen; click: to return to normal view.

PREFERENCES

The logged in user can view and update the personal details and notification preferences by:

- Clicking the **Preferences** option in the *Side Menu* on the *CPMS Global Dashboard*.
- Selecting **User Settings** from the *User Menu* in the *Header Menu*.

The *Preferences* page is organised into tabs; see below for a description of each one.

PERSONAL DETAILS

The user's name, display name, phone number and email address may be updated at any time.

The login name cannot be updated by the user; the support team must be contacted if a new login name is required – see the <u>ERN-CPMS Support Desk</u> section above for details.

Working on the *Preferences* page, click the **Personal Details** tab.

- 1. Make the required changes to the details.
- 2. Click Save Changes to update the user's profile.
 - o Click **OK** to confirm the changes.

Notes To facilitate the use of a nickname, the *Name to be displayed* is not automatically updated when the user's first, middle or last name are updated. The *Name to be displayed* must be updated separately.

- The *Email* address stored with the user's personal details is used by the ERN-CPMS system when sending panel notifications and <u>does not</u> change the user's login details. Users must contact the System Administrator to request a change to the email address associated with their login see the <u>ERN-CPMS Support Desk</u> section above.
- All times displayed in the ERN-CPMS are shown in the time zone for the country associated with the user's profile. Users must contact the System Administrator to request a change to the country associated with their user profile see the <u>ERN-CPMS Support Desk</u> section above.

NOTIFICATIONS

Email notifications are sent by the ERN-CPMS system to alert the user to new panel invitations or meeting requests, when updates to a panel have been made and to remind the user of upcoming tasks and meetings.

Some of these notifications are mandatory. The optional notifications, the frequency of task reminders and the timing of meeting reminders can be configured to the user's preference.

Working on the *Preferences* page, click the **Notifications** tab.

- 1. In the *Optional Notification* area, use the check boxes to turn specific notifications on or off.
 - Email notifications are sent for all mandatory and selected optional events as soon as they occur.
- 2. In the Task Reminders area, select a frequency for the Tasklist Reminders Digest Email.
 - No email is sent if there are no outstanding tasks.
- 3. In the *Meeting Reminders* area, select a time for the meeting reminder email.
- **4.** Click **Save Changes** to update the notification preferences.
 - Click **OK** to confirm the changes.

OTHER DASHBOARDS

Dashboards are used in the ERN CPMS system to provide an overview of activity and tasks.

- The ERN Dashboard provides an overview of activities and tasks within the selected ERN.
- The *Centre Dashboard* provides an overview of the user's activity within the user's Centre (Healthcare Provider).

Dashboards are made up of blocks (sometimes referred to as widgets), which group the panel or patient data, according to type. For example, the *ERN Dashboard* displays blocks relating to meetings, and the *Centre Dashboard* displays blocks relating to Patient enrolment.

Each block shows the first 10 records in each type with a summary of the detail. Click : in the top right of the block heading to expand to show more records and view more details.

The blocks displayed in the dashboards may differ depending on the user's role.

See the <u>The ERN Dashboard</u> and <u>The Centre Dashboard</u> sections below for further details.

GUEST USER (HEALTH PROFESSIONAL) ACCESS

As an occasional user, an external Health Professional may be given Guest access to the ERN-CPMS system to enrol patients and seek assistance. Unlike typical users in the ERN-CPMS system a Guest user does not belong to a Centre but is assigned to a private Guest Virtual Centre as their home Centre. Before accessing the ERN-CPMS system the user may be assigned Guest permission within their chosen ERN, if not they will be prompted to select an ERN when creating a Panel.

The *Side Menu* displayed on the *CPMS Global Dashboard* for the Guest user does not include an option to select a Centre. The ERN option is not available until the user has been assigned to an ERN. The Guest HP does not have full access to the ERN in which the Patient panel is created.

Access to the user's private Guest Virtual Centre is provided in the *Header Menu*.

The Guest Virtual Centre does not have a dashboard; the default page for the Guest Virtual Centre is the *Patient List* page. Guest users can enrol patients, view patients and participate in panels using the links in the Guest Virtual Centre *Side Menu*.

See the <u>Roles and Rights</u> appendix for full details of the Guest User permission with the ERN-CPMS system.

Note The Guest User should not be confused with a guest members within a Panel.

FIND A PATIENT RECORD

Patient records are associated with a Centre. All users from the centre can see all patients enrolled within the centre regardless of enrolling user.

- Working on the *Centre Dashboard*, the *Search* block can be used to search for a patient based on their First or Last Name, Record Label, CPMS ID, Panel ID, or Panel nickname.
- 1. Enter text in the *Search* box and click the \mathbb{Q} search icon,
 - A list of patients matching the criteria entered will be displayed.
- 2. Click a patient detail row to open the *Patient Panels* page for the selected patient.

- Working on the *Centre Dashboard*, click **Patient List** in the *Patients* block or *Side Menu* to open the *Patients List* page.

FIND A PANEL

Patient panels are associated with an ERN as well as a Centre and Patient.

Direct access to active Panels is provided from the CPMS Global Dashboard and Centre Dashboard.

The ERN or Centre *Panels* pages provide a list of all panels associated with the selected ERN or Centre.

- Working on the *ERN* or *Centre Dashboard*, click **Panels** in the *Side Menu* to open the *Panel List* page.
 - A list of all panels associated with the ERN or Centre is displayed.
 - The list can be filtered based to assist with locating a particular panel.
- 1. Enter text in the *Search* box provided and click the \mathbb{Q} search icon.
 - The search is applied to all fields except the date Started.
 - The list will be filtered to display a list of patients matching the criteria entered.
- 2. Click a Panel detail row to open the Patient Panels page for the selected patient.

WORKING WITH THE ERN-CPMS SYSTEM

THE VIRTUAL COLLABORATION PROCESS

Once a patient is enrolled on the ERN-CPMS system, a panel is opened, and collaboration can take place.

The Panel workflow is fluid – allowing member invitations or document uploads and meetings at any time before the Outcome is signed off.




Figure 8 - The Virtual Collaboration Process (Panel Workflow).

Documents can be attached to the patient record, or the patient can be transferred at any time after enrolment.

Archived Panels are available for reference on the patient's record.

ERN-CPMS PAGE STRUCTURE

Throughout the ERN-CPMS system, information pages can be accessed using the *Side Menu*. They provide a more detailed list of dashboard details, and are available while working with ERNS, Centres or Patients. The pages all use a similar format with options for filtering and sorting the data displayed.




Figure 9 - Example ERN Tasklist page

- **a.** The page title is shown at the top left of the page.
- **b.** Click 11 to open the report in full screen mode; click to 12 return to the main page.
- **c.** Enter text in the box provided and click the \mathbb{Q} search to filter the list.
- **d.** The ▲ ▼ buttons in the column header can be used to sort the page data.
- **e.** Click a **detail row** to open the selected record.
- **f.** By default, the page displays 10 rows at a time; pagination and navigation options are available at the bottom of the page.

In addition to the options above, ERN-CPMS pages may have other options:



Some pages include an action button, for example on the Centre and Patients pages there is an Enrol Patient button.



The **Download** button can be used to export the data from the ERN-CPMS page in .CSV format for use in MS Excel.



A **Menu** button may be displayed to the right of a details– the menu can be used to carry out actions on the selected item.



Some pages, for example, the ERN, My Meetings page, use tabs to separate list items by type. Click a **Tab** to move between lists.



The ERN, Panels list can be filtered using the drop-down menus at the top of the page.

- More than one filter can be selected.
- The filters applied are shown below the menu buttons.


ERN-CPMS CONSULTATION FORM

All recording of a patient's consultation details within the ERN-CPMS system is done using the Consultation Form.

The Consultation Form is made up of sections; sections can be added or removed as required by ticking the box to the left of the section title. Confirmation is required when removing a Section with data

THE SECTION SELECTOR



- The selected sections are indicated with a tick in the box to the left.
- b. The RAG indicator gives a visual indication of section completion. See the Form and Section Validation section below for details.

SAVE/CANCEL/CLOSE

Changes or new data must be saved to record the information in the system.




Figure 11 – Form Action Bar – see below for details

- **a.** The form will be flagged as missing data until all of the required data has been correctly entered. See the <u>Data Integrity</u> section below for details of data requirements.
- **b.** Use the **Save** button on the form to record the information.
- **c.** The **Cancel** button can be used to leave the form without saving the changes.
 - Confirmation of the action may be required.
 - o The Cancel button will be replaced by a **Close** button when there are no changes on the Form to be saved.



The Consultation Form includes a back-to-top button at the bottom of the page.

o Click the ↑ arrow to return to the top of the form.

It is recommended that users regularly use the Save button to ensure that data is not Note accidentally lost.

DATA ENTRY

Throughout the ERN-CPMS system, data is entered using a variety of methods:

- **Text boxes** allow the user to enter free text to describe a symptom, action, etc. Depending on the user's browser, spelling errors will be indicated.
- **Drop-down lists** allow the user to scroll through a list click an item in the list to select it.

- Auto-complete selection lists are used to allow the user to filter a long list start typing the required text and click an item in the list to select it. The magnifier to the right of the field will open a *Data Picker* page where the user can browse the full range of options for selection.
- Check boxes allow the user to select more than one option from a list click as many options as required to select them.
- **Radio buttons** allow the user to select a single option from a list click an option to select it. The previous selection will be removed.
- **Date pickers** are used to select a date from a calendar. Most date fields also allow the user to type the date. Some date fields do not require an exact date, for example a month and year may be sufficient.
- **Repeating fields** allow for multiple entries of similar data to be recorded within a section or form. A button will be displayed in the form section to allow the first and multiple entries.



The i symbol may be displayed beside fields that require complex or specific data. Click the i symbol to view an explanation of the data requirements.

PROGRESSIVE DISCLOSURE AND DYNAMIC FIELDS

Progressive disclosure is used within the Consultation form indicate the most important fields within a section of a form. Once this first field has been completed, additional (dynamic) fields are made available to complete the section.

REPEATING DATA

Repeating data fields allow more than one entry per section on a form.

Example: Consultation Form - Episode Description - Main Symptoms.

DATA INTEGRITY

The ERN-CPMS system uses Red/Amber/Green (RAG) colouring to indicate data validity and completion status on the *Encounter Form*.

All data on a form is checked and validated by the system as it is entered by the user. There are three particular checks carried out on the form.

The form data validation status will be indicated in the action bar at the bottom of the form.

The Save button for the form will not activate until all required data has been entered and is valid.

REQUIRED/EXPECTED/OPTIONAL DATA

Required data fields (also referred to as mandatory or compulsory) must be entered before a form can be saved. A red asterisk (*) is shown beside a field name to indicate that data must be entered in the field.

The form data status will change as sections are completed or edited.

The status of the form data will be indicated in the *Action Bar* at the bottom of the form and the **Save** button for the form will not activate until all required data has been entered.

Expected data fields are normally expected to be filled in, but the form can be saved if the fields are empty. An amber triangle (Δ) is shown beside the field name.

This will allow a user to save a form if they do not have sufficient information for a data field and it would be impractical to prevent the other data on the form being saved.

Empty or incomplete fields will not prevent the form being saved. The status of the form data will be indicated in the *Action Bar* at the bottom of the form and the **Save** button is active.

Optional data fields (also referred to as permitted or voluntary) do not have any completion requirement. No symbol is applied to these data fields. These data fields do not prevent the form being saved if they have not been filled.

Empty or incomplete fields will not prevent the form being saved. The **Save** button is active.

DATA VALIDITY

When entering data on forms, the system compares the values entered with required values that are set within the ERN-CPMS system. These comparisons can be either "Hard Checks" or "Soft Checks".

If there is an error when entering data, the system will display a message, describing the value that it did not expect and may ask for the correct value to be entered. The field will be highlighted with a coloured border.

Empty fields are treated in the same way as fields that contain data.

Hard Check Red Validation Error	The field contains invalid data. Missing data for a required field is considered as invalid data by the system. The relevant field is highlighted in red and the RAG indicator on the section is set to red. The form cannot be saved until the error has been corrected. Required fields are treated as <i>invalid</i> if they are empty.
Soft Amber Validation Warning	The field contains unexpected data. The relevant field is highlighted in amber, and the RAG indicator on the section is set to amber. The entry in the field may be changed, or if the value is correct the form can be saved with the errors included. Expected and Optional fields are treated as <i>valid</i> if they are empty.

FORM AND SECTION VALIDATION

The ERN-CPMS system uses Red/Amber/Green (RAG) colouring to indicate the completion status of information in a section. The same colouring scheme is used throughout the ERN-CPMS system.

Red Validation Error	Required but missing or invalid: required (mandatory) information in this section is required. The form cannot be saved until valid data has been entered in all fields on section.
Amber Validation Warning	Expected but missing: more information in this form or section is expected but has not been entered. The form can be saved but will be flagged to indicate that it is missing data.
Green Validation Success Optional: all required information in this form or section has been entered and is flagged to indicate that all data has been entered and is valid.	

THE CASCADING EFFECT (FIELD TO SECTION)

Within the ERN-CPMS system, the validation state of a Section is dependent on the fields in that Section. As the fields in a Section may have a mix of validation states, the Section validation state is determined by the most serious field validation error.

For example:

- If no data has been added to a Section, the Section border and heading and the indicator in the *Section Selector* will be Grey.
- If a Section contains any fields with a Red/Error validation state, the Section border and heading will be red and the indicator in the *Section Selector* will be Red/Error.
- If a Section contains no fields with a Red/Error validation state but one or more fields with an Amber/Warning validation state, the Section border and heading and the indicator in the *Section Selector* will be Amber/Warning.
- If a Section contains no completed fields with a Red/Error or Amber/Warning validation state the Section border and heading and the indicator in the *Section Selector* will be Green/Success.

USER PERMISSIONS

The user's role within the Centre or ERN will affect what they can to do when forming panels, working with a Panel or participating in meetings and elsewhere in the ERN-CPMS system.

What a Panel Lead or Member can do while working on a Panel will also differ depending on whether they are from the originating Centre (Healthcare Provider) or another Centre within the active ERN.

For these reasons, some of the actions described in this document may not be available to all users. Examples include:

- A Health Professional within a Centre can work with all panels in the Centre, whether they have been invited to participate or not, but cannot contribute to the outcome.
- A Health Professional within an ERN cannot view the clinical data for Panels they have not been invited to.

WORKING WITH THE ERN PAGES

The ERN pages provide direct access to active Panels associated with the ERN. All ERN members can view all panels associated with the network but cannot access any patient-identifying information outside of their own Centre.

Working on the *CPMS Global Dashboard*, choose an **ERN** from the *Side Menu* to open the *ERN Dashboard* for the selected ERN.

THE ERN DASHBOARD

The *ERN Dashboard* provides the user with an overview of their panel activity and tasks within the ERN. All detail rows on the *ERN Dashboard* are clickable to open the associated patient panel or ERN page.




Figure 12 - The ERN Dashboard - see below for details.

- a. Each block displays a list of panels, meetings, tasks or requests that require attention.
 - Depending on the user's role in the ERN, additional blocks may be available, e.g., Request Inbox,
 Transfer Requests, Panels Managed.

- c. Click a detail row to open the associated panel or meeting.
- **d.** Requests for assistance when forming a panel, Additional Data Requests, and Timeline Tasks (Actions) are displayed in the Requests for Additional Data section of the ERN dashboard.

THE ERN SIDE MENU

ERN PANELS

Details of panels in which the user is either the Panel Lead, Panel Manager or a participating member are displayed in the blocks on the *ERN Dashboard*.

The *Panel Invitations*, *Urgent Panels*, *My Panels*, *Contributing Panels* and *ERN Panels Managed* blocks display the first 10 of the user's active panels. All detail rows in the blocks are clickable to open the associated patient panel.

Click [3] in the top right of the block heading to expand and view additional panels that may be active. The expanded list includes details of the Panel Lead, thematic area and status.

The ERN *Panels* page provides a report of all active panels for the ERN with options to filter and search.

- Working on the *ERN Dashboard* for the selected ERN.
- 1. Click a **detail row** to open the selected panel.

ERN TASKLIST

Tasks include responding to panel or meeting invitations, requests for additional data, and meeting reminders. Depending on the user's role additional tasks may be displayed.

Once completed, the task will be removed from the ERN Tasklist.

Tasks will be automatically removed or updated as the panel workflow progresses.

Examples of task and actions include:

You have been invited to participate in a Panel.	Use the Accept or Refuse button in the <i>Panel Banner</i> to complete the task.
Please choose a preferred time to join a Panel meeting.	Use the Vote button in the <i>Panel Banner</i> to complete the task.

The task notifications will differ depending on the user's role within the Panel.

Tasks assigned to the user can be accessed in three places – see the sections below for details.

Working on the *ERN Dashboard* for the selected ERN.

THE MEMBER TASKLIST BLOCK

The *Member Tasklist* block displays the first 10 tasks awaiting the user's action.

Tasks are displayed in the *Member Tasklist* block by date – with the oldest at the top.

Click I in the top right of the block heading to expand and view any additional tasks that may be awaiting action. The expanded list includes the date the task was assigned.

- 1. Click a **detail row** to open the selected panel and take the action.
 - See the Working with a Panel section below for further details.

THE TASKLIST PAGE

The *Tasklist* page displays all tasks assigned to the user. The details on the page can be sorted and filtered (searched) to assist on locating specific tasks.

- 1. Click **Tasklist** in the *Side Menu* to open the *Tasklist* page.
 - The details of all tasks assigned to the user are displayed.
 - Enter text in the box provided and click the Q search to filter the list.
 - Use the ▲ ▼ to change the order of the details on the page.
- 2. Click a **detail row** to open the selected panel and take the action.

EMAIL NOTIFICATIONS

Email notifications are sent to the user at various times during the lifecycle of a panel. In most cases, a corresponding task will be displayed in the user's *ERN Tasklist* and in the Notifications area of the *Panel Banner*.

A digest email is sent, with details of panels the user is leading, upcoming meetings and any outstanding tasks to be completed. No email is sent if there are no outstanding tasks. The digest email may be received daily, weekly fortnightly, or monthly. See the <u>User Settings</u> section above for details.

Notification from Urgent panels are sent immediately, rather than waiting for the digest email.

As with the *ERN Tasklist*, the email notifications received will differ depending on the user's role within the Panel.

The emails are sent from the ERN-CPMS system email address *ern@ern-live-pri.cpms.ern-net.eu* and should not be replied to. Queries related to the email should be sent to ERN CPMS support team – see the <u>ERN-CPMS Support Desk</u> section above for details.

The subject line of the email will include the prefix "CPMS:" to help identification in the Inbox.

Some of the emails contain a link to the ERN-CPMS system login page. The meetings invitation and time proposal emails contain a link to accept the invitation or vote for a meeting time without logging in.

Examples include:

CPMS: You have been invited to participate in an Urgent Panel – this notification will be displayed in both the *ERN Tasklist* and *Panel Banner*.

CPMS: A Panel Member has mentioned you in a Comment – this notification will not be displayed in either the *ERN Tasklist* or *Panel Banner*.

CPMS: You are Invited to a Panel Meeting – this notification will be displayed in the both the *ERN Tasklist* and *Panel Banner*. The email contains a link to the *Meeting Invitation*, where the user can accept or reject the invitation without logging.

ERN MEETINGS

Details of the user's meetings can be accessed in two places:

- Details of all upcoming meetings are available through the ERN Dashboard.
- The ERN My Meetings page provides tabs to access to all upcoming and to review all past meetings.

THE MY MEETINGS BLOCK

THE MY PROPOSED MEETINGS BLOCK

The timeslot voting status for the user's proposed meetings is indicated in a block on the *ERN Dashboard*.

A meeting time for proposed meetings must be confirmed to make the meeting active and allow participants to join. The meeting time can be confirmed by the host before all invitees have voted.

- 1. Click a detail row to open the *Timeslot Confirmation* page for the selected meeting.
 - The time zone for the meeting will be displayed.
 - The invitation status and choices of meeting participants will be displayed.
- 2. Click an option to confirm the meeting time.
 - o Only one timeslot can be selected.
- **3.** Click the **Confirm** button to set the meeting time.
 - The proposed meeting is saved as a new individual meeting with the confirmed time and will be displayed in the *My Meetings* block on the *ERN Dashboard* for all invitees.

THE MY MEETINGS PAGE

Details all of the user's meetings are available on the ERN *My Meetings* page. Tabs are used to switch between *Upcoming* and *Past* meetings.

ERN WEBINARS

Webinars are used for education and training purposes and are specific to the ERN in which they were created. Similar to meetings, they are scheduled by the host, but no invitations are issued; all members of the ERN can join a live webinar or view recorded webinars.

A webinar differs from a meeting in that only the presenters screen is shared; participants cannot contribute or share their own screen.

All ERN members can schedule new Live webinars and upload a webinar using an MP4 recording from an external source.

- Working on the ERN Dashboard for the selected ERN, click Webinars in the Side Menu.
 - o The details of all panel webinars are displayed on the *Webinars* page.
 - o Tabs are used to switch between the Planned and Recorded webinars.
 - The *Webinars* page opens with the *Planned* webinars tab open.

SCHEDULE A WEBINAR

- 1. Click the **Schedule Webinar** button in the top bar.
- **2.** Type a **Title** for the webinar in the box provided.
- **3.** Type a brief **Description** of the webinar in the box provided.
- **4.** Type the name of the **Presenter**.
 - This will usually be the name of the user creating the webinar but may be different in the case of a hosted webinar.
- **5.** Select a **date**, **time** and **duration** for the webinar.
- 6. Click Schedule Webinar to save the webinar details.
 - Click **OK** to confirm the action and return to the *Planned Webinars* page.

DELETE A WEBINAR

STARTING OR JOINING A WEBINAR

The user that created the webinar can **Start** the webinar as the scheduled time approaches. Other users may **Join** the webinar once it has started.

Note It is recommended that users test the video and sound before joining or starting a Webinar by using the **Test Video** link provided.

 - The webinar details will be displayed.
 - A Test Video link and a countdown to the broadcast time will be displayed.
 - The countdown timer will become active 5 minutes before the webinar start time and can be used to start or join the webinar early.
 - If the start time has passed, a Start Webinar or a Join Webinar button will be displayed in place of the countdown timer.

 - A recording of the webinar is automatically made and will be available in the Recorded webinars area shortly after the webinar has ended.

OR

- 2. As participant, click the **countdown timer** or **Join webinar** button to view the broadcast.
 - The Webinar opens in a window at the bottom of the ERN-System page.
 - A message will be displayed if the presenter has not started the webinar.
- 3. Click the red leave button to leave the webinar and return to the Webinar details page.

Note The webinar toolbar and functions are similar to those for meetings. See the <u>Join a Meeting</u> section below for details.

VIEWING RECORDED WEBINARS

All past and uploaded webinars can be viewed from the Recorded tab on the ERN Webinars page.

- 1. Click a **detail row** to view the recorded webinar.
 - The webinar viewer will open and automatically start playing the recording.
 - A toolbar with options to control the progress, volume and screen size is shown below the recording.
- **2.** Click **Close** to stop viewing the recording and return to the *Planned Webinars* page.

ERN PREFERENCES

As a user's role or areas of interest within the ERN change, their preferences should be updated.

- 1. Working on the *ERN Dashboard*, click **ERN Preferences** in the *Side Menu* to open the user's *ERN Preferences* page.
- **2.** Make the required changes.
 - Tick/Untick the boxes to the right of the Thematic Areas of interest to identify the users areas of interest.
- 3. Click Update ERN Preferences to save the changes,
 - Click **OK** to confirm the action.

Note It important that this information is kept up to date to ensure that the user is listed correctly when inviting participants to panels and meetings.

PANEL MANAGEMENT (COORDINATOR)

The *Panel Management* page lists all Open and signed off panels for the ERN. The page provides the ERN Coordinator with direct access to panels and the option to assign a Panel Manager.

- Working on the ERN *Dashboard*, click **Panel Management** in the *Side Menu* to open the ERN *Panels* page.
 - o Use the **filter** drop-downs and **search** at the top of the page to refine the list.
 - o Click a **detail row** to open the selected panel.
 - See the Working with a Panel section below for further details.

ASSIGN PANEL MANAGER

A Panel Manager from the Patient's enrolling Centre may be assigned by the Panel Lead from the *Consultation Form*. The ERN Coordinator can assign Panel Manager from outside of the patient's Enrolling Centre.

- 1. Click the **! menu** to right of the panel details and select **Assign Panel Manager** to open the *Assign Panel Manager* form.
 - o If a Panel Manager is currently assigned, the name of Panel Manager will be displayed.
- 2. Use the **Panel Manager** drop-down to select a Panel Manager.
 - The list of users with a Panel Manager role within the ERN, with the number of panels they currently manage, is displayed
- **3.** Click the **Assign Manager** button to assign the selected user as Panel Manager for the selected panel.
 - o If a Panel Manager was previously assigned, they will be replaced by the new Panel Manager.

EXPERT GROUPS (COORDINATOR)

The ERN Coordinator may set up Expert Groups to simplify inviting panel members and meeting participants.

- Working on the *ERN Dashboard*, click **Expert Groups** in the *Side Menu* to open the *Expert Groups* page.
 - o The details of all Expert Groups within the ERN are displayed on the *Expert Groups* page.

Notes An Expert Group is available only within the ERN it was created.

The ERN coordinator may add themselves to a group.

CREATE AN EXPERT GROUP

- 1. Click **Create New Expert Group** at the top of the page to open the *New Expert Group* page.
 - Type a **Group Name** and **Description** in the boxes provided.
- **2.** A list of Available ERN Members is displayed below the group details; click **Add** to the right of the ERN Member details to add them to the group.
 - Use the **Thematic area filter** or type part of the member's name or hospital in the **Search by Name or Hospital** box to refine the list.
- **3.** In the list of Group Members, click **Remove** to the right of the ERN Member details to remove them from the group.
- **4.** Click the **Save** button to save the Expert Group.
 - A confirmation that the group has been added will be displayed.

The ERN Coordinator can schedule a regular meeting for the Health Professionals in the ERN. The meeting can be divided into timeslots to allow for the discussion of multiple panels or patients.

- Working on the *ERN Dashboard*, click **ERN Meetings** in the *Side Menu* to open the *ERN Meetings* page.
 - o The details of all ERN panel meetings are displayed on the *ERN Meetings* page.

SET UP A NEW ERN MEETING SCHEDULE

- 1. Click the **Create ERN meeting** button at the top of the page.
- 2. Enter all of the meeting details.
- **3.** Complete the **Scheduling** requirements.
 - o The Frequency and Occurs on options will differ depending on the Repeating unit.
- 4. Click Save to add the ERN meeting.

Note Once saved, the ERN meeting time slots are available to be selected by a Panel Lead when scheduling meetings. See the <u>Manage Panel Meetings</u> section below for details.

EDIT AN EXISTING ERN MEETING SCHEDULE

- 1. Click a **Detail row** on the *ERN Meetings* page to open the selected meeting details page.
- 2. Update the meeting details as required.
- **3.** Click **Save** to record the changes.

 - The date the report was generated is displayed in the page title




Figure 15 - Example Activity page - Total view - see below for details

- a. The date the Activity details were last summarised is shown at the top of the page.
- **b.** The buttons at the top of the page can be used to display a breakdown by week, month, quarter or year.
 - The page opens with the *Total* summary displayed by default.

Note The page may need to be scrolled right/left to view all details for the Weekly, Monthly or Quarterly reports.

PERFORMANCE (COORDINATOR)

The *Performance Indicators* page provides reports of user (Health Professional) and Panel activity on the ERN. These reports are useful when the ERN Coordinator is responding to a request for assistance when assigning a Panel Lead or when assigning a Panel Manager.

- Working on the *ERN Dashboard*, click **Performance** in the *Side Menu* to open the *Performance Indicators* Report.
 - The page opens with the Active Users tab displayed by default.

The **filters** and **search** at the top each tab can be used to refine the list. Click a **tab** to switch between the reports.

Performance Indicators - Active Users - The *Active Users* tab displays a list of Health Professionals participating in the ERN. The list can be filtered by Join date and Last Login date.

Performance Indicators – Panels Closed - The *Panels Closed* tab displays a list of ERN panels closed with summary details of the panel including Panel Lead and Panel Manager. The list can be filtered by date closed and by thematic area.

Performance Indicators – Panels Created - The *Panels Created* tab displays a list of all ERN panels, including closed, with summary details of the panel, including Panel Lead and Panel Manager. The list can be filtered by date created and thematic area.

Performance Indicators – Thematic Area - The *Thematic Area* tab displays a list of all ERN thematic areas with the associated Health Professionals. The list can be filtered by thematic area and ERN.

WORKING WITH THE CENTRE PAGES

The Centre pages provide direct access to all Patients and active Panels associated with the Centre. All Centre members can view the details of all patients and panels associated with the Centre, whether or not they are a member of the ERN or panel.

Working on the *CPMS Global Dashboard*, choose a **Centre** from the *Side Menu* to open the *Centre Dashboard* for the selected Centre.

THE CENTRE DASHBOARD

The Centre (Healthcare Provider) *Dashboard* provides an overview of the user's activity within the user's Centre (Healthcare Provider). From the *Centre Dashboard* the user can view a summary of patient enrolment, search for individual patients and see an overview of recent activity within the Centre.

Generally, a user (Health Professional) will be associated with only one Centre. However, if they are in more than one Centre, they can select the Centre to work with from the Centres drop-down list in the *Header Menu* or from the Centres option on the *Side Menu* of the *CPMS Global Dashboard* or *ERN Dashboard*.




Figure 16 - The Centre (Healthcare Provider) Dashboard - see below for details

- **a.** The *Patients* block shows the number of patients enrolled within the Centre and provides links to enrol a new patient and view current patients in the Centre.
 - Patients requiring review, due to transfer, will be listed in this block. Click **View** to open the patient record.
- **b.** The *Search* block allows the user to quickly find a particular patient, based on their first name, last name, ERN-CPMS system ID, panel ID or nickname.
 - For example, type part of the patient's name in the box provided and click **Search** to list patients with names that match the text.
- **c.** The *Recent Activity* block lists the patients that have recently been enrolled or updated. Click **Patient ID** to open *Panels* page for the selected Patient.

Depending on the user's role in the Centre, additional blocks may be available, e.g., Panels I Managed.

THE CENTRE SIDE MENU

While working within the *Centre Dashboard* and its associated pages, e.g., while enrolling a patient, the menu displayed on the left of the screen provides access to Centre related features.



The options in the *Side Menu* will change, depending on the feature the user is working with.

- **a.** The currently selected ERN and Centre are highlighted click the ERN or Centre title to return to the *ERN* or *Centre Dashboard*.
- **b.** The currently selected page is highlighted and indicated by a **<** notch in the menu.

ENROL A PATIENT

The first task in the virtual collaboration process is the enrolling of patients.

- Working on the *Centre Dashboard*, click **Enrol Patient** in the *Patients* block to open the *Enrol Patient* page.
- A unique *Patient Id* is automatically assigned by the ERN-CPMS system.
- The *Record Label* will be automatically generated it is made up of the patient's name, date of birth and gender.
- The other fields on this form are self-explanatory.
- 1. All **Consents** must be indicated. A date and a note may be required if consent is allowed; see the Consent section below for details.
- **2.** When all of the consents and the patient's details have been added, click **Enrol Patient** at the bottom of the page to save the new patient record.
 - o Tick the box ☑ and click I Confirm to acknowledge Data Protection responsibilities and complete the patient enrolment.
 - o Click Cancel to return to the patient enrolment form without saving the record.

Once the patient enrolment has been completed, the *Panel Creation* page is opened allowing the user to open the first panel for the newly enrolled patient. See the <u>Working with a Panel</u> section below.

Notes All authorised users from the enrolling Centre can see all patients enrolled within the Centre regardless of enrolling user.

• No direct patient-identifying information is contained in the Panel Consultation Form – it is only visible in the enrolment form.

CONSENT

The patient must give consent to be enrolled in the system.

The enrolling Health Professional must indicate that consent has been given using the fields on the enrolment form. Three types of consents are available:

Consent for care. This is the minimum required consent for enrolment and to set up a consultation panel for the patient. The **Yes** option must be selected, and the date of consent provided as the patient is enrolled in the ERN-CPMS system.

Consent for ERN databases/Registries: This consent is optional and is used to authorise Panel Leads to make the pseudonymised clinical data available in low accessibility databases after panels have been closed and an outcome has been signed off.

Consent contact for research: This consent is optional; it indicates that patients are interested in being contacted for specific research projects outside of ERN-CPMS.

Consent forms are available in the local language for all member states taking part in the ERN project.

Click Download Model Consent Forms to download example PDF forms or Consent reference guides. Confirmation may be required depending on the browser settings.

PATIENT LIST

The Centre *Patients* page provides a report of all patients enrolled in a Centre. See the <u>ERN-CPMS Page</u> <u>Structure</u> section above for further details.

- Click Enrol Patient to enrol a patient.
 See the Enrol a Patient section above for further details.
- Click a **Detail Row** to open the *Panels Page* for the selected Patient.

 See the <u>Working with the Patient Record</u> section below for further details.

CENTRE PANELS

The Centre *Panels* page provides a report of all panels for a Centre. See the <u>ERN-CPMS Page Structure</u> section above for further details.

WORKING WITH THE PATIENT RECORD

Once a patient has been enrolled, the patient record is associated with the enrolling Centre.

The patient record provides access to the patient details (consent and patient-identifying data), panels, attached documents and transfer requests.

- Working on the *Centre Dashboard*, click **Patient List** in the *Side Menu* or in the *Patients* block to open the list of patients enrolled in the Centre.
- ▶ Click a **Patient Row** to open the *Panels* page for the selected patient.

THE PATIENT RECORD SIDE MENU



While working with a Patient Record, the menu displayed on the left of the screen provides access to Patient specific tasks.

- a. Use the freturn arrow above the menu to return to the original page
- **b.** The currently selected ERN and Centre are highlighted click the ERN or Centre title to return to the *ERN* or *Centre Dashboard*..
- c. The currently selected page is highlighted and indicated by a **<** notch in the menu..

PATIENT DETAILS

The *Patient Details* page allows the user to update the patient's details, e.g., to correct a spelling error or change the consent settings.

UPDATING PATIENT DETAILS

The Patient details can be edited from within the *Patient* pages at any time.

- 1. Working on the Patient's record, click **Patient Details** in the *Side Menu* to open the *Patient Details* form for the selected patient.
- 2. Make the changes necessary and click **Save Patient** to record the changes.
 - Click **OK** to complete the action.

Note If a patient's consent for care is revoked, all open panels must be cancelled. A warning message will be displayed on the patient's page to remind users to cancel any on-going or future consultation requests for that patient.

WIPE PATIENT DATA

When the consent for care is revoked the patient record should be removed from the system.

- 1. Working on the Patient's record, click **Patient Details** in the *Side Menu* to open the *Patient Details* form for the selected patient.
 - The Wipe Patient's Data section is at the bottom of the form.
- 2. Click Wipe this Patient's data to start wiping the record.
 - Click **Cancel** to return to the *Patient Details* form without wiping the record.
- **3.** Tick the box ☑ and confirm that the patient will be notified that the record has been removed from ERN-CPMS.
- **4.** Choose an option (**Yes** or **No**) to indicate if the patient requested the data to be removed.
 - o If Yes, the **Date of Request** must be recorded.
 - o If No, the **Reason for Deletion** must be recorded.
- 5. Click Wipe Data to remove all of the patient's data from the ERN-CPMS system.
 - Click **OK** to complete the action.

Note This action removes all patient data from the ERN-CPMS system and cannot be reversed. If you intend to work with this patient again, you will have to re-enter the data.

RE-CONSENT

Patient consent for participation in the ERN-CPMS system must be confirmed after a transfer has been accepted.

Patients requiring review of consent will be displayed in the Patients block on the Centre Dashboard.

A warning will be displayed at the top of all patient pages until the patient consent is reviewed. Working on the *Centre Dashboard*, click the **View** button beside the patient details to open the *Panels* page for the selected patient.

- 2. Click the **Update Patient Consent** button to open the *Update Consent* page.
 - Update the patient consent details as required.
 - o Click Cancel to return to the *Patient Details* form without updating the record.
- **3.** Tick the box \square to confirm the data has been reviewed and updated consent has been given.
- 4. Click the **Update consent** button to save the updated consent,
 - Click **OK** to complete the action and return to the original page.

Note Patient data should be removed from the ERN-CPMS system if the patient's consent is more than 15 years old. See the <u>Wipe Patient Data</u> section above for details.

PATIENT PANELS

The patient's *Panels* page is the first page displayed when a patient is selected; it contains details of all panels for the selected patient. See the <u>ERN-CPMS Page Structure</u> section above for further details.

Working on the Patient's *Panel Page*, click a **Detail Row** to open the selected Panel. See the <u>Working</u> with a <u>Panel</u> section below for further details.

COPY PANEL

In certain cases, the information recorded on an existing panel will be relevant for a new panel. To avoid the need to re-enter the data, an existing panel can be copied.

- 1. Working on the Patient's *Panel Page*, click the menu link to the right of the panel detail and select **Copy** from the menu.
- 2. Select the sections to be copied to the new panel and click **Copy Panel** to save the new panel.
 - Click **OK** to complete the action and open the copied panel.

Notes The new panel will be created with the same nickname as the original and should be edited immediately to avoid confusion with the original panel.

• The new panel will be created without a panel lead assigned; the current user is assigned as the panel lead when the Consultation form is edited for the first time.

ABORT PANEL

In certain cases, a panel becomes unnecessary after it has been opened; such panels can be aborted to ensure no further information is gathered.

- 1. Working on the Patient's *Panel Page*, click the menu link to the right of the panel detail and select **Abort** from the menu.
- **2.** Type a reason for aborting the panel in the box provided and click **Abort this Panel** to abort the panel.
- 3. Click **OK** to confirm the action and return to the Patient's *Panel Page*.

Notes All patient panels must be aborted when a patient withdraws consent from participation in the ERN.

Aborted Panels are available for reference on the patient's record.

PATIENT DOCUMENTS

Patient report documents and images may be attached to a patient's record. Once attached they can be viewed using the built-in attachment viewer.

Notes Documents attached to a patient record are not available to the patient panels and are not visible to users outside of the enrolling Centre. For this reason, documents associated with a patient panel should be attached through the panel, rather than the patient record- see the Panel Attachments section below.

- Medical Documents (DICOM) can be attached to the Consultation Form see the <u>Consultation</u>
 Form <u>Attachments</u> section below.
- Working on the Patient's record, click **Patient Documents** in the *Side Menu* to open the *Patient Documents* page.
 - A list of all documents attached to the patient record, including those uploaded within a panel will be displayed.

See the Attachments section below for details of working with patient documents.

TRANSFER A PATIENT RECORD

This feature is primarily used to allow users with temporary access to the ERN-CPMS system, e.g., a Guest User (Health Professional) in a Guest Virtual Centre, to transfer patient records to the ERN coordinator as their access to CPMS expires.

Note Patient records must be assigned to an ERN coordinator so that the data ownership is maintained within the ERN. If a patient record has not been transferred and the enrolling guest clinician is de-activated within the ERN-CPMS system, the patient remains in Guest Virtual Centre, and is not accessible within the ERN.

ERN Coordinators are nominated and managed by DG SANTE. One user within the ERN is assigned as Transfer Coordinator to deal with transfer requests. The ERN Coordinator is usually assigned as the Transfer Coordinator, but occasionally different person may be assigned – see the <u>Roles and Rights</u> appendix below for details.

- The transferred patient record is fully available to the recipient Centre but no longer available to the transferring Centre.
- Transferring of a patient record is permanent.
- Transferred patient data is removed from the *Dashboard* and patient list in the originating Centre and is included on the *Dashboard* of the recipient Centre.

Notes If the Transfer Request is declined, the patient record is automatically removed from the ERN-CPMS system when all active panels have been closed.

- If the ERN transfer Coordinator is in the same Centre as the user, there is no need to transfer the patient; a message is displayed on the patient's *Transfer Request* page.
- Working on the Patient's record, click **Transfer Request** in the *Side Menu* to open the *Record Transfer Request* page.
 - o If a request has already been requested, details of the existing transfer will be displayed.

STARTING A PATIENT TRANSFER

- 1. Use the **drop-down** list to select the receiving Centre for the patient record.
 - o Other Centres within the ERN are listed, with the name of the Coordinator shown.
- 2. Type a message to the receiving Coordinator in the box provided.
- 3. Click the **Request Transfer** button to complete the transfer request.
 - Click the **Yes** button to confirm that the Patient has consented to the transfer of their identifying data.
 - Click the **OK** button to close the transfer request.

Notes There may be a delay in implementing a Transfer; the patient will remain at the originating centre until the Transfer is completed.

- There is no option to update or cancel the Transfer Request. If a patient is transferred in error the transfer should be <u>accepted</u>, and the patient should then be <u>transferred back</u> to the <u>originating</u> centre.
- The Download Model Request form button provides access to Model patient transfer request forms in a selection of EU languages. These forms can be used as part of an off-line transfer request.

VIEWING A PATIENT TRANSFER

After submitting the Patient transfer request, the current status of the submitted Request is displayed on the patient's *Transfer Request* page. There is no option to update or cancel the Transfer Request after it has been submitted.

If the patient transfer has been rejected, the status will be displayed as Rejected if there are open panels for the transferred patient.

ACCEPTING/REJECTING A PATIENT TRANSFER (COORDINATOR)

The ERN Coordinator will be notified by email and the patient transfer request will be indicated on the Coordinator *ERN Dashboard*.

- 1. Working on the *ERN Dashboard*, click a **detail row** in the Record Transfer Requests block to open the *Confirm Transfer Request* pop-up.
 - o The transfer request details are displayed
- 2. Click the **Accept** button to accept the transfer and move the patient to the receiving centre.
 - The patient consent must be reviewed and updated at the receiving centre. See the <u>Re-Consent</u> section above for details.

OR

- 2. Click the Reject button to refuse the transfer.
- 3. Click **OK** to confirm the action and return to the *ERN Dashboard*.

Notes If the transfer has been accepted, the patient record and associated panels and data are immediately transferred to the receiving centre. The patient will be highlighted for review on the *Centre Dashboard* at the receiving centre.

 If the patient transfer is rejected, the patient record and associated panels and data will be deleted. If there are any open panels for the patient, the patient record will remain at the originating centre until all panels have been closed or aborted.

WORKING WITH A PANEL

The first panel associated with a patient is opened as the patient is enrolled. Additional panels can be opened by Health Professionals working within the enrolling Centre.

The Panel workflow is fluid. Once the *Consultation Form* has been saved for the first time, members can be invited to join, documents can be attached, and meetings can be scheduled by the Panel Lead as the contributions are recorded and the outcome is drafted.

Tabs are used to switch between the *Consultation Form* and other panel areas.

Note The information displayed and the actions available will differ depending on the user's role. For example, only the Panel Lead may sign off the Outcome. See the <u>Roles and Rights</u> appendix for more details.

CREATE A NEW PANEL

The *Panel Creation* page will be automatically opened when a new Patient enrolment is completed. Additional panels can be created for the patient as needed.

The *Consultation Request* section of the *Consultation Form* must be completed and saved before other panel tasks can be carried out.

- Working on the Patient's record, click **Panels** in the *Side Menu* to open the *Panels* page for the selected patient.
- 1. Click **Create a New Panel** to open the *Panel Creation* page.
 - Items indicated in red with an asterisk (*) must be completed.
 - Fields may be enabled depending on information recorded in other sections/fields.
 - The nickname is used in all panel lists and *ERN dashboard* blocks; it should not contain any patient-identifying data.
 - A panel can be flagged to indicate that Urgency is required for the case. Panels flagged as Urgent are displayed in the Urgent Panels block on the *ERN Dashboard*.
 - The user (Health Professional) that opens the panel is automatically assigned as Panel Lead; an alternative can be set using the drop-down list. 


Figure 19 - Example - ERN CPMS Panel Banner

COMMENTS AND ACTIONS




Figure 22 – Example Consultation form

FAMILY HISTORY / PEDIGREE

The pedigree tool is attached to the Family History section of the Consultation form. It can be used to track the patient's ancestry in the form of a family tree, and to show the family members who possess a relevant genetic mutation, classified either as affected or as a carrier

1. **Tick** the Family History box in the section selector to add the Family History and Pedigree sections from the form.




Figure 23 - Example Pedigree (Family Tree) Chart

- **a.** The text boxes in the top left corner next to Affected and Carrier allow the user to describe the condition in question. This helps to avoid confusion in cases where comorbidities have been declared by the patient in addition to the original condition of interest.
- **b.** The toolbox in the top right corner provides options to zoom (in and out), view full-screen, print and export the Pedigree chart (family tree).
 - These options are available in View mode.
- **c.** Use the buttons along the bottom of the screen to add, edit or remove family members of the patient/proband.




Figure 24 - Example Panel Members



Meetings within ERN-CPMS system use built-in video conferencing technology which requires additional resources. See the System Requirements appendix below for details of all requirements.

Notes Use of the MS Explorer or Safari browser is not recommended - users may experience problems when joining video meetings or sharing screens.

- The share the screen functionality is not supported on older versions of Microsoft Edge.
- To ensure the best performance of audio and video during meetings, other applications that
 use the microphone or camera such as Skype, Zoom, etc. should be closed while using the ERNCPMS system for meetings.
- Working on a *Panel* page, click the **Meetings** tab to open the *Meetings* page.
 - o The details of all panel meetings are displayed on the *Meetings* page.

The panel *Meetings* page is divided into three sections:

- Upcoming Meetings: meetings scheduled in the future view all details, add comments.




Figure 27 - Panel Meetings page




Figure 30 – The Meeting Timeslot Selection Page.




Figure 31 - Meeting in Progress - screen shared

THE ATTACHMENT VIEWER

The built-in attachment viewer opens in a pop-up modal. Once the *Attachment Viewer* is open, all attachments for the selected panel or patient can be viewed using the left-hand navigation bar.

The built-in viewer will automatically detect the file format and opens the attachment in the appropriate tool; the layout and options available may differ depending on the browser settings.




Figure 32 - The Built-in Attachment View with a DICOM image open.

- a. Click the sarrow at the top of the left-hand navigation bar to switch between attachment types.
- **b.** Other attachments of the same type will be listed in the left-hand navigation bar click an **attachment** title to switch between attachments.
- **c.** The file details are displayed above the attachment display window.
- d. Click the [] : Maximise/Minimise button at the top of the page to hide or display the left-hand navigation.
- e. Use the **X** Close button at the top of the page to close the *Attachment Viewer* pop-up and return to the original page.

Depending on the file type, a **Download** button may be available at the top of the page.

o Confirmation may be required depending on the browser settings.

Notes Medical Document (DICOM) images and files are displayed using the MedDream viewer.

- The built-in viewer used for visualisation of other image attachments is not a diagnostic tool.
- Editable files (e.g., Microsoft Office, Open Format) cannot be viewed using the built-in viewer. The download option should be used for these files.

PATIENT-IDENTIFYING DATA

The ERN-CPMS system will remove patient-identifying data from DICOM images while uploading them. The software will also remove identifying sections from attached CDA documents. However, it may be unable to remove the data completely.

The software will not attempt to modify other file types, e.g., spreadsheets, document or images, to remove patient-identifying data.

Note It is the user's responsibility to ensure that all patient-identifying information is removed before documents or images are attached to the patient record.

Notes *Medical Documents (DICOM) can be attached to the *Medical Documents* section of the *Panel Consultation Form* or to a Patient Record.

• The file extension for all files uploaded must be lower case. For example, Word filenames must be example.docx rather than example.DOCX.

MEDICAL IMAGE VIEWERS

As well as standard file types, such as PDF Files, there are two medical image viewers embedded within the ERN-CPMS system.

The ERN-CPMS system will automatically use the appropriate viewer to open files as they are selected.

STUDY TYPES SUPPORTED

The following types of exams are supported by the viewers:

- CT scans
- MRIs
- PET scans
- Tomography
- Echographs

- RXs
- Dicom-ised Static Images
- Endoscopies
- Histopathology

DICOM VIEWER

Medical Document (DICOM) images and files are displayed using the MedDream viewer; it can be used to display radiology scans with full annotation tools.

The viewer is currently certified with CE-marked as a Class 1 medical device, which means that the tool can be used for diagnostic purposes.

DIGITAL PATHOLOGY VIEWER

The Digital Pathology Viewer (also called Whole-Slide Imaging viewer or WSI viewer) will display specimen images in high definition.

Note Users dealing with .ndpi formats should ask the support team for assistance with a conversion process the upload and viewing of this material. See the ERN-CPMS Support Desk section above for contact details.

ATTACH USING FTP

The ERN-CPMS system provides the option to upload large files, that exceed the 1Gb size limit for the standard attachment, using secure FTP. Secure FTP Upload also provides more control over file uploads, e.g., scheduling or throttling internet bandwidth usage.

The Medical Documents section of the panel *Consultation Form* includes an option to allow the user to view the Secure FTP configuration settings and set up a password to enable the use of secure FTP.

Files uploaded through FTP will be available for rename etc. using the attachment viewer on the *Medical Documents* section of the *Consultation Form*.

Note Upload using FTP requires that third party FTP client software, such as FileZilla or WinSCP, is installed. The user should ask the IT department at their organisation for assistance in configuring and using the FTP client software.

- Working on a Panel, click the **Consultation Form** tab to open the *Consultation Form* and select the **Medical Documents** Section.
 - > Small to medium sized files should be uploaded using the **Attach File/Image** button.
- 1. Click the **Attach Using FTP** button to open the *Secure FTP Details* pop-up.
- 2. Click **Set FTP Password** to set or change the user's password.
- **3.** Type a password in the box provided.
 - A password must be at least 10 characters we recommend a combination of upper- and lower- case letters, numbers and special characters.
- **4.** Confirm the password in the second box.
- **5.** Click **Set Password** to save the password and return to the Secure FTP details. OR
- 5. Click Clear to remove the password.
 - The Secure FTP access will be removed.

APPENDICES

ROLES AND RIGHTS

Users working within the ERN-CPMS system are assigned roles within each Centre they work with. The role assigned will affect the actions that the user can take while working with the Centre module – their rights or permission. In some cases, a user may be allocated roles in more than one Centre, with different rights in each one.

Within the ERN module, the users is assigned a role within each ERN they are a member of; additional roles may be assigned within the Panels the user joins. These roles affect the level of participation, and the patient data visible, within the Panel.

A user may be assigned more than one role within a Centre or ERN; the rights and permissions are combined to allow the permissions at the highest level from all roles.

Access rights within a Panel also differ if the user is a guest from another network.

A Health Professional (HP) is usually a Doctor of Medicine, a nurse responsible for general care, a dental practitioner, a midwife or a pharmacist within the meaning of Directive 2005/36/EC, or another professional exercising activities in the healthcare sector which are restricted to a regulated profession. The HP is usually the person who will meet patients within their centre and report for the ERN / panel.

GUEST HEALTH PROFESSIONAL USER VS GUEST PANEL MEMBER VS EXPERT ERN GUEST

A *Guest Health Professional* is a user that has been given temporary access to the ERN-CPMS System, usually to allow consultation on a single patient. The Guest HP is not associated with a Centre; instead, a private Guest Virtual Centre is assigned to the user.

A *Guest Panel Member* is a full ERN-CPMS System user that is a member of an ERN and is associated with a Centre. This User has been invited to participate in a Panel from outside of the ERN for the panel.

An *Expert ERN Guest* is a full ERN-CPMS System user that is a member of an ERN and is <u>not</u> associated with a Centre. This User can be invited to participate in Panels from within their ERN, or invited to join a Panel in another ERN as a Guest Panel Member.

CENTRE PERMISSIONS

Notes Users within a Centre have permission only within their own Centre and cannot access data in other Centres.

In some cases, a user may be allocated roles in more than one Centre.

Note A Guest User must have an EU login in order to access the ERN-CPMS System.

SYSTEM REQUIREMENTS

As well as the browsers and settings listed in the <u>Supported Browsers</u> section above, the following requirements should be confirmed.

SOFTWARE

To avoid problems with the camera or microphone, other video conferencing applications (e.g., Skype, Zoom, Teams etc.) should be closed while participating in Panel Meetings or Webinars.

Where possible, to ensure a stable connection, video streaming through another browser or application (e.g., YouTube) should be avoided when participating in Panel Meetings or Webinars.

HARDWARE

In order to participate actively in video conferencing, the PC, laptop or tablet used should be equipped with a camera and microphone and must be enabled within the browser. Depending on the browser settings, confirmation of access to the camera and microphone may be required.

Note It is recommended that users test the video and sound before participating in Panel Meetings or Webinars by using the **Test Video** link provided.

INTERNET SPEED/BANDWIDTH

Depending on the modules being used, an internet speed from 528 Kbs to 4Mbs is required; higher speeds are needed to maintain a stable video connection when participating in Panel Meetings or Webinars.

The internet access speed can be checked using the http://www.speedtest.net websites. Users may experience low quality or dropped video connections if the available internet speed/bandwidth falls below a reasonable threshold.
