Introduction

- To use the CPMS 2.0, two actions need to be completed:
 - 1. Create an EU Login account with 2-factor authentication activated
 - 2. Request access to CPMS 2.0
- Follow the steps in this guide to be able to use CPMS 2.0



Go to the EU Login sign-up page

2-Factor Authentication

- To use 2FA (2-factor authentication) with your EU Login Account, a Mobile Device needs to be linked
- Additionally, the EU Login App needs to be installed on your phone and initialised

Download the EU Login app on your Mobile Device


Search for "EU Login" on your mobile device's app store or go to one of those links



















At your account page, go to "Manage my mobile devices" and add your phone





Fill out the fields an click submit




Initialise the EU Login App

After you have submitted your PIN, a QR code will be generated on the computer you are using. You will need to scan this QR code in the EU Login App to initialise it, as described on the following pages.

If you already have a mobile device connected to your EU Login and only want to initialize the app, you may need to delete the device and add it again to get the QR code.




Initialise the App



- In the EU Login app on your phone, select "Initialise" to scan the QR code on your computer screen
- In the App, you will need to confirm the initialization with your PIN (created on page 14)
- You can now use the EU Login App



Using the EU Login App




When logging in to EC IT services (CPMS), enter your password and select the option to use the EU Login Mobile App PIN Code. When you do so, you need to open the app on your phone to put in the PIN you chose when setting up your EU Login account.

It might take a couple of seconds for the login prompt to show up when opening the app.


If your phone uses biometrics (e.g. fingerprint, face recognition), this method can be chosen on the phone instead of entering the PIN.


Submit Access Request
